These technologies cannot be part of work for companies with confidentiality agreements or subject to secrecy clauses, otherwise the technologies do not necessarily have to be mature for protection or licensing because it is just an exercise. It would be good to propose at least one technology/invention per research unit. Those who register to attend without being part of a technology team may choose later to join one of the teams that are formed.

In order to submit a technology or invention, provide the following information to Félix Marín:

- ✓ Title of the technology or invention
- ✓ Short description and reasons why it is proposed (100 words maximum)
- ✓ Team (maximum 10 members): Names and surnames.
